As part of its commitment to the 2021 United States hosted Summit for Democracy, Canada made a number of commitments to address corruption. One commitment was to "explore options to strengthen the international legal framework and architecture to combat corruption globally". In 2022, Global Affairs Canada (GAC) held consultations on this issue with experts, including Transparency International Canada (TI Canada). During the same time, the Canadian International Council (CIC) contracted TI Canada to lead a report on anti-corruption as part of the Restoring our Democratic Alliance (RODA) program, funded by the Konrad Adenauer Stiftung Canada.

Among the recommendations that TI Canada provided was that Canada needs to integrate anti-corruption in its foreign policy.

Objective:

This conference will provide Canadian policymakers, academics, and civil society with insights on why it is important to integrate anti-corruption across different aspects of Canadian foreign policy and how it can be done.

JAMES COHEN

Executive Director, Transparency International Canada

James also worked for Transparency International's Defence and Security Programme from 2011–2013, where he focused on corruption risk to the military, police, and peacekeeping, as well as advising governments and civil society, including TI chapters.

Susan is currently the Chair of Transparency International Canada and also sits on the international Board of Transparency International. Susan's career with the international secretariat of Transparency International spanned almost two decades. She worked for the organization in London, Washington D.C., and Berlin. As Head of Transparency International's Business Integrity Programme, she led projects aimed at raising standards of corporate anti-corruption practice and represented TI on initiatives such as the United Nations Global Compact, the Partnering against Corruption Initiative of the World Economic Forum and the B20.

Subsequently, Susan worked for the Conference Board of Canada where she managed an executive network of risk professionals and carried out research in the governance, compliance and risk areas. Susan is past president of IMPACT, a Canadian non-profit organization dedicated to addressing the problem of conflict minerals. She was recently appointed as a Trustee of the Board of the National Gallery of Canada.

Previously, he had an assignment as the Foundation's Representative to Indonesia and East Timor since February 2002. Before, he worked for KAS in Thailand in the same function between 1997 and 2001. He began his career as a journalist and later became a researcher at the Institute of Political Science of the Johannes Gutenberg University, Mainz, Germany. His publications include articles and books on development strategies of ASEAN countries, EU-ASEAN relations, the role of the German political foundations in development cooperation, the political system of Thailand as well as aspects of the political and legal reform processes in Thailand and Indonesia.

He is currently a senior fellow at the University of Ottawa Graduate School for Public and International Affairs.

From 2015 to 2018, he held the position of Chief Information Commissioner of Afghanistan, where he played a crucial role in establishing the country's Access to Information Law. This law is internationally recognized as one of the most exemplary legislations in the world (www.rti-rating.org).

Mr. Afzali has been instrumental in championing transparency and accountability through various initiatives, including the Construction Sector Transparency Initiative (CoST), the Extractive Sector Transparency Initiative (EITI), the Open Government Partnership (OGP), and the establishment of the Access to Information Commission of Afghanistan.

JENNIFER LOTEN

Director General, International Crime and Terrorism, Global Affairs Canada

Jennifer Loten is a career foreign service officer currently assigned as Director General, International Crime and Terrorism Bureau at Global Affairs Canada (GAC). Since joining Global Affairs Canada in 1997 she has served abroad in a variety of capacities including as Ambassador and Permanent Representative of Canada to the Organisation of America States; Consul and Head of Office, Consulate of Canada, Anchorage, Alaska; and Political Advisor, Embassy of Canada, Brazil. Over the course of her career she has headed numerous delegations, chaired international meetings, and participated in electoral observation missions representing Canada.

Jennifer Loten holds a Master of Philosophy in Social Anthropology from the University of Cambridge, and a B.A. in Anthropology from Trent University in Peterborough, Ontario.

AKASH MAHARAJ

Ambassador-at-Large, Global Organization of Parliamentarians Against Corruption

Akaash represents the international alliance of democratically-elected legislators in its work combatting corruption, strengthening good government, and upholding the rule of law. He also leads GOPAC's project on international prosecution of Crimes Against Humanity and its work on reconciliation in post-conflict states. The United Nations selected him to speak for the world's legislators in the General Assembly Chamber, on bringing kleptocrats to justice.

Earlier in his life, Akaash was an international athlete for Canada, and was a triple gold medallist at the International Championships of Equestrian Skill-at-Arms. He earned his Master of Arts from Oxford University, and was the first overseas student elected President of the student government in the history of the 900 year-old University. He completed further studies at 3 the Sorbonne Université and the United Nations University.

SABINE NÖLKE

Former Ambassador / Trustee of the Board of the National Gallery of Canada

Sabine Nölke joined Global Affairs Canada in 1992, specializing in international peace and security, human rights, terrorism, humanitarian law and international and transnational criminal law. Her last Ottawa assignment was as Director-General of the Non-Proliferation & Security Threat Reduction Bureau, where she was responsible for Canada's disarmament and non-proliferation policy, the WMD Threat Reduction Program, and Canada's counterterrorism and anti-crime capacity building programs.

She served abroad at the High Commission of Canada in London; with the Canadian delegation to the Organization for Security and Co-operation in Europe in Vienna, where she focused on the human and economic dimensions and the former Soviet Union space; and finally, as Ambassador to the Kingdom of the Netherlands and Permanent Representative to the Organization for the Prohibition of Chemical Weapons, as well as the international tribunals and institutions in The Hague (2015-2019).

Co-founder and Executive Director, Canadian Centre of Excellence for Anti-Corruption (CCEAC).

Mr. Pat Poitevin is an internationally recognized expert in anti-corruption, financial crime, corporate ethics, and compliance. Mr. Poitevin is a 35-year veteran of the Royal Canadian Mounted Police and retired in October 2017, where he was the RCMP's anti-corruption and compliance expert. He has also been an investigator and expert on drugs, organized crime, and financial crime. He is in demand as a speaker, university lecturer, and trainer at the national and international level and has extensive experience in program development and capacity building.

Mr. Poitevin has been advising and helping public and private organisations to improve their ethics, compliance, and anti-corruption measures. He has also worked on research, consultative, and advisory projects with the G20, UNODC, and the IMF.

KADY SÉGUIN


Policy and Research Director, IMPACT.
